- Recognition of management abilities by superiors, peers, and employees.

ELIGIBILITY REQUIREMENTS

An active member of the ACCQ for under two years with a career horizon of at least a decade as of November 5, 2026.

NOMINATION PROCEDURE

- The nomination must be submitted by the local president and seconded by a member of the local executive.
- The form must be completed, duly signed, and returned by email to candidature@accq.qc.ca no later than October 9, 2026. Only the information included in the said form will be analyzed by the jury.
- One application per local section will be accepted.
